- (1) **Employment, Office, Trade, Profession or Vocation** – Any employment, office, trade, profession or vocation carried on by (the Councillor) for profit or gain.
- (2) **Sponsorship** – Any payment or provision of any other financial benefit (other than from the Parish Council) made or provided within the last 12 months in respect of expenses the Councillor has incurred in carrying out their duties as a Member of towards their election expenses. This includes any payment or financial benefit from a Trade Union within the meaning of Trade Union and Labour Relations (Consolidation) Act 1992.
- (3) **Contracts** – Any contract which is made between the Councillor or a body in which they have a beneficial interest and the Parish Council a) under which goods or services are to be provided or works are to be executed; and b) which has not been fully discharged.
- (4) **Land** – Any beneficial interest in land which is within the area of the Parish Council (this includes the Councillor’s home or any land or buildings from which they receive rent.)
- (5) **Licences** – Any licence (alone or jointly with others) to occupy land in the area of the Parish Council for a month or longer.
- (6) **Corporate tenancies** – Any tenancy where, to their knowledge, the landlord is the Parish Council and the tenant is a body in which the Councillor has a beneficial interest.
- (7) **Securities** – Any beneficial interest in securities of a body where: a) that body, to their knowledge, has a place of business or land in the area of the Parish Council and b) either i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or ii) if the share capital of that body is more than one class, the total nominal value of the shares of any one class in which you, of the persons referred to above, has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

- (8) **Management or control** – Any body which the Councillor is in a position of general control or management and to which they are appointed or nominated by the Parish Council.
- (9) **Public, Charitable and other External Bodies** – Any body: a) exercising functions of a public nature; b) directed to charitable purposes or c) one of whose principal purposes includes the influence of public opinion or policy (including any Political Party or Trade Union) of which the Councillor is a member of in a position of general control or management.
